### 4. BOARD EDUCATION

#### 4.1 Accreditation Debrief - S. Maier

- 23 priority process across both sites were looked at by the Accreditors
  - One Required Organizational Practice (ROP) was unmet around narcotic safety
    - We have appealed this ROP and should know the outcome of that appeal in March
- Highlights since the last survey included:
  - Recognition of staff
  - Redevelopment
  - New CT
- Challenges since the last survey included:
  - Ongoing physical plant

- Strengths that were identified are:
  - Quality reporting, scorecards and decision support and analysis
  - Financial stability
  - Capital equipment and community fundraising
- Opportunities included:
  - Coming together as "one" hospital
  - Continue to move towards full electronic chart
  - Maintaining OB volume
  - Accreditation Canada identified the recruitment of patient partners as an opportunity for LWHA
    - The board will discuss this opportunity as a group at a later date
    - Is there a risk of "full time patients" acting as a parallel advisory committee to the board?
    - Keep in mind that most board members have been patients and can provide than perspective
    - Some organizations designate a board member to bring the patient perspective to each meeting
    - A patient advisory committee that meets quarterly could be a very healthy link to look at from a governance point of view
      - May be an opportunity to recruit for future board members
- Next steps

- Await the results of appeal
- A debrief for the Leadership team is scheduled for March 8<sup>th</sup> submission of 2 supplementary
- Submission of supplementary evidence prior to October for two standards:
  - Diagnostic Imaging 8.9 (cleaning and reprocessing diagnostic devices and equipment)
  - Perioperative Services 4.10 (transporting contaminated equipment between clean bins)

### 5.1 Board Retreat 2018

### 5.2 Chief Nursing Executive Report - S. Maier

Highlights from S. Maier's report included:

- As of January 29, visiting hours will be flexible to accommodate patients' circumstances; there will be no prescribed hours
- Patients will be assured that their families are welcome at their side regardless of the time of day
- A guideline has been put in place and supports staff and patients to limit visitors when appropriate for the purposes of rest, care delivery, outbreak, privacy, and safety/security issues

### 5.3 Chief Executive Officer Report - K. Ellis

Highlights from K. Ellis' report included:

- With the retirement of B. Boshart fast approaching the senior leadership team would like to welcome S. Albrecht to the Chief Operations Officer role effective February 1<sup>st</sup>, 2018
- North Huron Wingham Police
  - The Township of North Huron is considering options for OPP coverage vs. the Wingham

Police Force

- The Wingham and District Hospital does rely on the Police for a fast response in emergency situations
- If access to a timely police response is not available we would have to hire security which could impact budgets at both hospitals by at least \$500,000
- The response time has been raised with the Township of North Huron with the location of the new OPP office in Clinton
- No decisions will be made by the Township until late February, at the earliest
- Richard W. Levan Airport in Wingham was considered a Huron County asset in a recent commissioned review
  - The Wingham and District hospital will continue to use the helipad at the airport for Ornge Air ambulances

- Currently there is nothing scheduled for Board Education in May
- After discussion it was determined that the May education session will be a story from a patient who was recently discharged from the Wingham and District Hospital rehabilitation program along with a program presentation by the Manager.
